The Canadian Federation of University Women, Kitchener-Waterloo Charitable Fund (**CFUW K-W Charitable Fund**) was established in 1985 as a registered charity organization to cultivate excellence in public education in Canada and to encourage the higher education of women.

CFUW Charitable Fund manages nine endowment funds. Revenue from these funds provides twenty-seven awards (including the Elliot T. Grasett Award\*), scholarships and bursaries given out to high school students, undergraduate and graduate students in Kitchener-Waterloo. There is also one national award given to a graduate student at a recognized university anywhere in Canada. In 2008-2009, \$22,200 was distributed providing many students with recognition and financial support.

The funds that finance these awards depend upon the generosity of members and the public at large through individual donations and from such fundraisers as the annual Used Book Sale.
